### Question of the week: How much money is the District going to receive if the bond passes?

If the voters approve the bond in the November elections, Lowell School District would receive the following funds:

\$4 million from the Bond  
 + \$3 million OSCIM grant award from the State of Oregon  
 + \$1 million from the Seismic Grant from the State of Oregon  
 = \$8 million guaranteed funds

The State has also committed to awarding Lowell an additional \$1 million of OSCIM grant funds IF our bond is approved by the voters AND another grant award recipient does not receive voter approval for their bond. That would bring the total to \$9 million.

# LOWELL SCHOOLS: We're on the *Move...*

From Lowell Superintendent Walt Hanline:

The Lowell School District took an aggressive approach to finding funding solutions for the district in response to the State Legislature allowing for the issuance of bonds to finance capital costs. This matter has been placed on the November ballot. As your School Superintendent, it is my role to ensure that you are provided accurate and timely information on what the District intends to use these funds for should this matter receive voter approval.

It is imperative that should the local bond be approved by the voters of Lowell School District, the funds will be used for the repair of the "guts" and security of our two buildings. The safety of our students is our number one priority.

The repurposing of the Lowell High Gym will come out of the state matching funds and will not take place until priorities stated below are addressed. Simply stated, if we have enough money for the gym we will build one. If we don't have enough to finish all of the gym, we will have to rely on the district and other avenues to complete that project sometime into the future.

Work for the Lowell School District Bond will be completed based on the following funding priorities:

Priority 1: Make needed **safety and security upgrades** in both school buildings;

Priority 2: Modernize and renovate the interior of both schools including **new upgraded mechanical, plumbing, and lighting**; and,

Priority 3: Build a new gym and wrestling room and convert the existing high school gym into a multipurpose center / performing arts space / cafeteria, and add classrooms.

**Priority 1: Safety and security upgrades:**

- ◆ Site access controls and security cameras;
- ◆ Seismic improvements to Lundy Elementary;
- ◆ Electronic door entrances;
- ◆ Replacement of old interior and exterior doors with locking doors compliant with security criteria;
- ◆ ADA improvements for safe access for all students;
- ◆ Office renovations at Lundy Elementary for better visual and security control; and,
- ◆ Perimeter fencing at Lowell HS to secure building.

**Priority 2: Modernize vital building systems:**

- ◆ Plumbing updates to replace corroding and rusting water supply and waste lines, as well as outdated inefficient fixtures;
- ◆ Replace and upgrade electrical systems to handle modern power needs;
- ◆ Replace oil-based boilers with new decentralized energy efficient HVAC units;
- ◆ Replace classroom lighting with energy efficient LED fixtures;
- ◆ Remove or encapsulate lead paint at walls and ceilings; and,
- ◆ Remove remaining asbestos tiles and glue.

**Priority 3: New Lowell HS Gym/convert existing gym into a multipurpose center/performing arts space/cafeteria**

(the following bullet points are **listed in order of priority**):

- ◆ Build a New Gymnasium and Wrestling Room building shell and interior finishes;
- ◆ Install New Gymnasium athletic equipment (score boards, back boards, etc);
- ◆ Repurpose existing Gym and wrestling room by:
  - ◇ Converting existing HS concessions and classroom to new kitchen, using existing kitchen equipment;
  - ◇ Removing existing bleachers and add storage space for tables, chairs and props for performances;
  - ◇ Reconfiguring stage and add curtains, lighting, etc.;
  - ◇ Converting existing cafeteria to new science lab / classroom space; and,
  - ◇ Convert existing wrestling building into a weight room.
  - ◇ Install New Gymnasium bleachers; and,
  - ◇ Install in the New Gymnasium a divider curtain for practices.

I trust this information is useful to you. The School Board has never wavered from being transparent about this process and has taken great pains to ensure that we will be conservative in our approach should this bond be approved. With that said, both the Architect and I believe **we will have sufficient funding** to complete all the projects in the above order. ### GEAR UP: College...it's not a dream, it's a plan.

Sixty-four 9th and 10th graders visited the U of O campus to learn a university computer research system at the Knight Library and view the Oregon Native American exhibits at the Natural History and Culture Museum. Teachers C.J. Cramer and Heidi Sawitzke used a collaborative teaching style to combine the aspects of how religion has influenced government. Students learned how to use the university system to navigate their research topics for their classes. At the museum, students were exposed to various hands-on artifacts, from digging tools to bone fishing hooks.

GEAR UP plans to take other classes to college visits throughout the school year, exposing them to other universities, community colleges and technical schools in Oregon.

The GEAR UP grant was received in 2014 and provides \$40,000 per year through 2021. The mission of this effort is to assist students to attend colleges and trade schools after their high school graduation.

## Grant Received for Parks Master Plan

The City has received a \$32,000 grant from the Oregon Parks and Recreation Department to update the 2007 Parks and Open Space Master Plan. An additional \$8,000 in matching funds will be provided by the City to complete the project. This grant will allow the City to review each element of the existing plan, develop master plans for each park, and strategies for project implementation. A steering committee will be established to manage the development process, which will include several opportunities for public engagement. More information will be provided as we get closer to kicking off the project.



## Seasonal Clean Ups Announced

The City of Lowell will host two city-wide cleanups in the Fall and Spring to provide residents an opportunity to dispose of common household materials (see list below). Events will be held at Lowell City Hall, located at 107 East Third Street. This year the selected dates are Saturday, October 14 and Saturday, May 5. Materials will be accepted from 9:00-12:00 a.m., or until the dumpster containers are full. Proof of residency will be required, and may be confirmed with a recent water, electric, cable or telephone utility bill.

Please carefully review the following list of acceptable materials. The items listed below are examples of what will be accepted at each seasonal cleanup. The City reserves the right to refuse oversized loads, business waste or unacceptable materials.

### Acceptable Materials

- Plastics
- Scrap Metal
- Furniture
- Bagged clothing
- Ink Cartridges (no cracks or leaks)
- Clean Appliances
- Tires (limit of 4, no larger than 17 inch)
- Small Electronics

### Unacceptable Materials

- Household Garbage
- Construction Waste
- Fluorescent Lights
- Alkaline Batteries
- Household Chemicals
- Computers, Monitors, and TVs
- Yard Debris (acceptable at City Green Waste Collection Site)

## New Outdoor Burning Regulations

New outdoor burning regulations became effective on June 15.

The following burning is allowed subject to compliance with Lane Regional Air Protection Agency (LRAPA – [www.lrapa.org](http://www.lrapa.org)) rules and advisories:

- Fires initiated for firefighting training purposes
- Recreational fires used for cooking with fire in a fireplace, barbecue set, or an outdoor fireplace, fire ring, or pit fueled with cut and split firewood
- Bonfires or religious ceremonial fires approved by LRAPA and the LRFPD
- Burning of clean woody yard trimmings, leaves and grass clippings on LRAPA approved burn days in October, March, April and May

The following burning is prohibited:

- Burning of any refuse, garbage, or other waste products
- Burning of any construction or demolition waste
- Field, ditch or weed burning
- Commercial or industrial burning as defined by LRAPA
- Burning of wet woody yard trimmings, leaves and grass clippings

**Green Waste Collection Site**

To assist with disposal of yard debris, the City will start accepting green waste at the Wastewater Treatment Plant, located at 240 South Moss Street. The facility will be open the last Saturday of every month from 10:00-12:00. Residents may drop off acceptable materials at no charge. Proof of residency is required, and may be confirmed with a recent water, electric, cable or telephone utility bill.

Acceptable Materials

- Tree limbs
- Leaves
- Soft, pliable vines
- Twigs, branches, and woody vines up to 6" diameter and 10' long
- Similar garden waste

Unacceptable Materials

- Dirt or sod waste
- Animal waste
- Herbicides, Fertilizers, or Insecticides
- Treated Logs or lumber
- Stumps or stump grindings
- Material from contractors or commercial firms

The Lowell Rural Fire Protection District has had a busy summer. On August 10, 2017 we had a fire start nearby our district from a lightning strike that has burned more than 10,000 acres. We have had 4 management teams come through with over 700 personnel. The Fire District has helped out by providing a place for the management teams to hold meeting as well as provide a sleeping area for the firefighters during the very hot days that we had.

We have added 8 new volunteers to the district. We are looking forward to the future and bringing on more volunteers to continue building the ranks to provide to the 23 square miles of the fire district.
