

Outdoor Contact Sports Opt-In Form

This form is to be used by a school located in a county designated as High Risk or Extreme Risk to notify of its intent to opt in to offer outdoor contact sports for the 2020-21 school year in accordance with the Governor's February 10, 2021 update to <u>Outdoor Contact Sports Guidance</u>. Once final, this form will be posted to a school or district website and a link to it will then be sent to ODE.

In Lower Risk and Moderate Risk counties, practices and games for outdoor contact sports, including high school football, can resume following health and safety guidance to be issued by the Oregon Health Authority.

In High Risk and Extreme Risk counties, where COVID-19 remains more widespread, schools and other sports organizations can opt-in to resuming outdoor full contact sports with additional protocols in place. In such counties, sports organizations must offer on-site responsive testing for symptomatic individuals and close contacts, contact information for contact tracing, and a waiver identifying health and safety risks and a commitment to isolation and quarantine if exposed to COVID-19. Schools in Extreme and High Risk counties must also have at least limited in-person instruction occurring, with the goal of achieving hybrid or full in-person instruction for students this school year. Schools must also be in compliance with state guidance for COVID-19 testing.

School Instructional Model

Lowell Jr/Sr High School has offered Limited In-Person Instruction since the beginning of the school year. All students were given the opportunity to come to school for up to two hours a day. On February 16th, the school began operating in a Hybrid model. The students were split into two cohorts attending in-person a week at a time. The cohort not attending in-person attended virtually.

Plan Details for Contact Information for Contact Tracing

Lowell Jr/Sr High School has been following state and OSAA protocol for all practices since August 2020. Coaches are required to screen all athletes prior to practice and complete contract tracing logs. If any coach/athlete is showing symptoms or has been in contact with an individual with COVID-19, they are not allowed to participate. Visiting high schools will be asked to provide contact tracing logs providing similar information. All officials or support staff will be expected to go through the same process described above. Fans will not be allowed in the facility.

Student-Athlete Waiver

OHA Requirements

- The school must have a waiver completed for each student-athlete prior to outdoor contact sports participation identifying health and safety risks and a commitment to isolation and quarantine if exposed to COVID-19.
