From the August 5th regular meeting:

- Approved Resolution 601—Employee Pay Scale
- Approved Resolution 606—Intergovernmental Agreement for Operational Maintenance Services between Lane County and City of Lowell.

Both motions were approved unanimously by: Paulson, Rennert, Burford, Knokey and Reese.

From the August 12th special meeting:

- Approved a motion to enter a 30-day wastewater operations contract with Orenco Systems, contingent on review of the contract by the Mayor and Council President.
- Approved a motion to enter into negotiations with Max Baker for the position of Public Works Superintendent subject to three conditions specified in the motion.

From the August 19th regular meeting:

- Approved a motion to solicit three bids from Certified Public Accountants to review one year of records
 and to notify the city immediately if any evidence of financial problems that may constitute fraud are
 found; also to contact Rebecca Price, CPA to solicit a report detailing changes made to correct the fund
 imbalances that delayed the FY 2010-11 audit.
- Approved Resolution 608—Amending the city of Lowell's Personnel Policies & Procedures Employee Manual Relating to Pay Dates.
 - Both motions were approved unanimously by: Paulson, Rennert, Burford, Knokey and Reese.

FROM THE LOWELL FIRE DISTRICT

District Prepares For ISO Evaluation

The Fire District has been contacted by ISO (Insurance Services Office, Inc.) to provide information concerning the district's ability to respond to and manage structure fires. ISO is a private for profit company that provides a statistical numerical value to properties, so that those insurance providers may equate the number value to insurance premium costs relevant to fire protection.

ISO has provided an assessment schedule for the district to review. The purpose of the schedule is to outline the criteria for evaluating the fire prevention and fire suppression capabilities of individual communities, or fire protection areas. The purpose of such an evaluation is to develop a Public Protection Classification (PPC) for property insurance rating.

The schedule measures the major elements of a fire protection area's fire prevention and fire suppression systems. The fire suppression component evaluates how those systems address reported structure fires. The schedule gives procedures and formulas for developing the measurements into a Public Protection Classification number on a relative scale of 1 to 10, with 10 representing less than the minimum recognized protection.

The Schedule is a property insurance rating tool, and is not intended to analyze all aspects of a comprehensive public fire protection program.

A Public Protection Classification (PPC), developed by the schedule is only one of several elements used to develop the property insurance loss cost and underwriting information for an individual property. Other features specifically relating to the individual property such as construction, occupancy and hazards, exposures and private fire protection, are also important in the evaluation of property insurance loss costs and underwriting. A large number of insurance companies do not use the PPC for underwriting, but utilize an individualized system of evaluation and establishing premium rates.

The PPC will be developed from evaluation and scoring in three specific areas. These areas are indicated as a percentage of the total rating value. The percentage for each scoring area included is:

A. Receiving and handling fire alarms
B. Water Supply
C. Fire Department
50%

Item A, Receiving and handling fire alarms is performed and managed through Central Lane Communication operated by the Eugene Police Department, and managed by a users group comprised of all the users of the 911 system in Lane County. This users group includes all Fire departments and district located in central Lane County and the Eugene Police Department.

Item B, Water Supply, evaluates the City Water System storage and distribution network. Due to the recent improvements to the City Water System, such as increased storage capacity and additional hydrants to the system, the district can expect to see significant improvement in this area of the evaluation.

Item C, Fire Department Service, evaluates the District structure fire response and service capabilities, which has also seen significant improvement over the past several years. As this evaluation is specifically pointed to the City assessment, we would expect to see improvements associated with the districts enhancements in fire prevention activities and improved training levels of district personnel.

It is anticipated that the evaluation process will take several months to complete and another several months to be processed by ISO. Within the City it is unlikely that the ISO class would change, but the total assessment percentage values will very likely improve. At this point it is unclear if ISO will be evaluating the rural area of the district, but like the City, it is unlikely that the PPC will change, but total assessment percentage values should improve.
