


## November is Check Your Smoke Alarm Month

November is the month that everyone should take the time to check their Smoke Alarms for proper operation and to ensure the batteries are good. Newer Smoke Alarms are required to have 10-year batteries in them, and alarms over 10 years old should be properly disposed of and replaced with the newer models. In addition, smoke alarms should have the "hush" feature so that when a false alarms does occur, the alarm can be temporarily silenced to allow the inadvertent (burnt toast) smoke to clear.

The chart below shows the most common causes of smoke alarm failure in Oregon. Almost 70% of failures are due to missing, disconnected or dead batteries!

## LOWELL SCHOOLS: We're on the Move ...

Big changes are afoot this year in the Lowell School District Food Service Department! This year, not only were students treated to a tastier and more appealing food menu, they also had their dining areas revamped to make their eating

experience more enjoyable. At Lundy, the cafeteria area has been remodeled to include a covered entrance and added windows to improve natural lighting. At the high school, new tables and chairs were purchased to give the dining area a more relaxed and positive atmosphere. Another change this year is that the seventh and



eighth grade students have lunch at the high school rather than having to walk across the field to the elementary school to eat.

Some of the menu changes include offering three main food options for students. At Lundy the students can choose from two cold food entrees which include yogurt and cereal or a deli sandwich. Students can still choose a hot lunch entrée over cold food if they prefer. All students are welcome to servings of fruit or salad in addition to the entree



choices. At the Jr./Sr. High School the students have salad and fruit offerings as well as their choice of five to six different entrees daily. Similar to past years, all of our Lundy and Lowell High School students are able to take advantage of breakfast in the morning at the elementary school and a nutrition break at LHS.

As a result of these changes, the number of students eating lunch at the high school has increased by close to 100%. We are pleased that so many students are taking advantage of the new school menus. We are also pleased that many of our students have taken advantage of filling out the "free and reduced" lunch applications. The applications make it possible for the Lowell School District to be eligible for additional school funding in the form of grants and student reductions on the cost of various standardized tests such as the ACT and SAT.

Next year the Food Service Department hopes to be in a position to utilize the produce grown by NEXUS Gardens, a school-based student enterprise. #### **NEXUS GREENWORKS FALL/WINTER REPORT**

Since the beginning of the school term in September, the Nexus Greenworks students and crew have been busy with fall harvest activities and yes, preparations for next year's gardening. If you visited the garden and greenhouse during the summer you know that our student interns, Noah Stewart and Jason Byrne worked throughout the summer watering and weeding and later harvesting our produce. The Dem-"Farming is Everybody's Bread & Butter" onstration garden produced three varieties of sweetcorn, pumpkins, winter squash, A STUDENT OWNED SCHOOL BASED ENTERPRISE





onions, tomatoes, peppers, eggplant, zucchini, garlic, broccoli, kale and tons of summer and fall flower varieties. The beautiful vines that grew over the garden were hops which produced over seven lbs. of cones. Our fall plantings include winter onions and garlic, and in the greenhouse five varieties of salad greens. All of the outside raised beds and the demo garden have been either replanted or cover-cropped with field peas, vetch, fava beans, crimson clover and rye. This is a "green manure" planting that will be tilled back in the spring to enrich the soil. 13 students participating in Nexus/YTP this term are now propagating new seeds for succession plantings in the greenhouse. These students are also continuing in the classroom with career exploration activities and making plans to again visit Sweet Creek Foods with a new surprise recipe to complement our fantastic organic blackberry and strawberry fruit spreads that we have been promoting and selling at events throughout the community (We still have a few cases remaining.) Look for our new product around Thanksgiving. It's going to be great!! More news from Nexus and the Youth Transition Program will follow in upcoming newsletters. #### November is "Check Your Smoke Alarm Month" — continued from Cover page

Here is a list of the most common questions about smoke alarms and the answers to these questions as provided by the Oregon State Fire Marshals Office.

Q. Why should my home have smoke alarms? A. You are four times more likely to survive a home fire if you have a working smoke alarm. During a fire, you may have less than three minutes to escape. Smoke spreads fast, and smoke alarms alert you to the danger and give you time to get out.

Q. What is the difference between a smoke alarm and a smoke detector? A. A smoke <u>alarm</u> is a self-contained, single or multiple-station smoke-sensing device. A smoke alarm detects and alarms. A smoke <u>detector</u> is a smoke-sensing device that is not self-contained and operates as part of a central control system. A smoke detector detects smoke and sends the information to an alarm panel. (ORS 479.250).

Q. What types of smoke alarms are available? A. Ionization, photoelectric, combination (ionization/photoelectric), and smoke (ionization or photoelectric)/carbon monoxide alarms. For more information on the types of alarms, their power source, and hush feature requirements see the chart at www.lowellfiredistrict.org.

A conventional audible smoke alarm does not fully address the needs of people who are deaf or hard of hearing. Q. What is the difference between ionization and photoelectric smoke alarms? A. Ionization smoke alarms are quicker at sensing flaming, fast moving fires. Photoelectric smoke alarms are quicker at sensing smoldering fires. Both types are recommended for protection from both types of fires.

Q. Where do I install smoke alarms? A. Smoke alarms in dwelling units shall be installed in each sleeping room as per the applicable requirements of the State Building Code at the time of construction and in the corridor or area giving access to sleeping areas according to the manufacturer's instructions\*.

Where sleeping areas are located on an upper level, the smoke alarm or smoke detector shall be installed in an accessible location as close as practical to the center of the ceiling directly over the stairway. Where sleeping areas are widely separated (i.e., on different levels or opposite ends of the dwelling unit) and/or where a single smoke alarm or smoke detector will not adequately service all sleeping areas, a smoke alarm or smoke detector shall be installed adjacent to each sleeping area. (OAR 837-045-0050)

- Outside bedrooms within 21 feet of all bedroom doors.
- On each level of the home (including the basement).
- In bedrooms, if required by state building code at the time of construction.
- All smoke alarms are to be installed according to the manufacturer's recommendations.

\*Please note: required when selling or renting a home.

Q. Are smoke alarms required on every level? A. Yes. Smoke alarms are required on each level of the home (including the basement).

Q. Are smoke alarms required in all bedrooms? \*\* A. Smoke alarms in dwelling units shall be installed in each sleeping room as per the applicable requirements of the State Building Code at the time of construction. The OSFM recommends adding smoke alarms to each bedroom or other areas used for sleeping to increase protection.

\*\*Please note: Some local ordinances have additional requirements.

Q. Where should smoke alarms not be installed? A. Kitchens, bathrooms, garages, and unheated areas where moisture, steam, frost, cooking vapors, and exhaust fumes could cause a nuisance alarm.

Q. Should a smoke alarm be installed in the kitchen? A. No. If you install smoke alarms in the kitchen, install them at least 10 feet away from cooking appliances. They should be equipped with a hush feature or be photoelectric smoke alarms. (NFPA 72)

Q. How often do I replace my smoke alarm? A. Smoke alarms should be replaced according to the National Fire

Protection Association, National Fire Alarm and Signaling Code (72-14.4.7) Replacement of Smoke Alarms in One and Two-Family Dwellings: "Unless otherwise recommended by the manufacturer's published instructions, single and multiple station smoke alarms installed in one- and two-family dwellings shall be replaced when they fail to respond to operability test, but shall not remain in service longer than 10 years from the date of manufacture." (NFPA 72)

Q. Can I replace a hard-wired smoke alarm with a smoke/carbon monoxide (CO) alarm? A. Yes, you may replace a hard-wired smoke alarm with a hard-wired with battery back-up smoke/CO alarm.

- Switching from one manufacturer's unit to another may require a power adapter plug.
- Manufacturers advise adapter plugs may be changed using wire nuts and may require a licensed electrician.

Q. Are 10-year batteries and a hush feature required in smoke alarms in Oregon? A. All <u>ionization</u> smoke alarms sold in this state that are solely battery-operated shall be packaged with a 10-year battery. All ionization smoke alarms sold in this state shall include a hush mechanism that allows a person to temporarily disengage the alarm for a period of not more than 15 minutes. (ORS 479.297)

"Ten-year smoke alarm battery" means a battery power source that is warranted by the battery manufacturer to be free from defects in materials and workmanship for a period of at least ten (10) years when used in an ionization smoke alarm that: Is listed by a nationally recognized testing laboratory; and has been approved by the nationally recognized testing laboratory for use with a ten-year battery. (OAR 837-045-0040)

Photoelectric, combination (ionization/photoelectric), and smoke/carbon monoxide alarms do not require a 10-year (long life) battery or a hush feature, but are available for sale in Oregon.

Q. How do I keep my smoke alarm working? A. Smoke alarms must be maintained, tested, and batteries replaced according to the manufacturer's recommended instructions. (OAR 837-047-0150)

Follow the manufacturer's recommendation for the type of battery to use in your smoke alarm. Never disconnect or remove smoke alarm batteries for other uses.

Smoke alarms with a non-replaceable (long-life) battery are designed to be effective for up to 10 years. If the alarm chirps, immediately replace the entire smoke alarm.

For smoke alarms with any other type of battery, replace the battery at least once a year. If the alarm chirps, replace only the battery.

Q. How and when do I test my smoke alarm? A. Test smoke alarms once a month by pushing the test button.

Q. What should I do when the smoke alarm sounds? A. Get outside and stay outside. Get low and crawl low under the smoke to your way out. Call 9-1-1 or your local emergency number for help. Never go back inside for people, pets, or belongings.

Q. What do I do if my smoke alarm sounds and it is a nuisance alarm? A. Many smoke alarms come with a hush feature, a button on the alarm that you push to silence nuisance alarms for up to 15 minutes.

Please note: Nuisance alarms can be caused by steam from showers or smoke from cooking.

#### **Backyard Open Burning Season Officially Opens**

Backyard Open Burning is now allowed only during days and hours authorized by Lane Regional Air Protection Agency. Remember, before you light that burn pile, make sure it is an authorized burn day by calling LRAPA at 541-726-3976, Option #3. Burning outside the authorized parameters could expose you to fines from LRAPA. Burning of yard debris, tree trimmings and yard clippings is allowed on designated burn days as established by LRAPA. # **City Beat**

#### **City Administrator Terminates Contract**

Recently, the Lowell's City Administrator, Bill Lee, gave notice to the City Council that he will be stepping down as City Administrator effective January 15, 2015. The City Council has been conducting work sessions to develop the process for the recruitment and selection for the next City Administrator.

#### **Lowell Covered Bridge Gate**

A couple months ago, the large pull down gate at the Lowell covered bridge was damaged by someone driving their vehicle across the walkway to the bridge and ramming the gate which caused the gate to come off its tracks. The City Administrator has reported the damage to Lane County Parks Maintenance who is responsible for all major maintenance.

The County is looking at alternatives rather than complete replacement since the replacement would cost over \$10,000. The City Administrator, with a consensus of the Council, has proposed a temporary solution to the County by swapping the damaged gate with the gate at the south end of the bridge. We are hoping the County will have this done soon for our Christmas Lighting Ceremony on December 6th.

#### **Medicare Review Time**

Is your Medicare plan working for you? October 15th through December 7th is the Annual Enrollment Period for Medicare and the only time Medicare beneficiaries can change their Medicare Advantage and Part D plans.

After December 7th you have to wait another year to make a change. Certified volunteer counselors from Lane County Senior Health Insurance Benefits Assistance (SHIBA) program are trained to provide unbiased information about current plans and can assist you to

make the best choice for your situation.

#### Lowell City Council Actions

This report of actions taken by the Lowell City Council is a regular feature of this newsletter and is provided to inform citizens of recent decisions made by the council.

#### From the October 7th regular meeting:

- Approved directing the City Administrator to get a written quote from Ms. Couch to do a cash receipt review for fiscal year 2010-2011 and execute a contract if the quote does not exceed \$1,750. In support: Paulson, Rennert, Reese, Knokey, Burford; Opposed: none.
- Approved directing staff to prepare an amendment to the City land use code that would include among the commercial uses not allowed in Lowell any commercial use that involves a violation of Federal law, and to bring this matter to the Planning Commission. In support: Rennert, Reese, Knokey, Burford; Opposed: Paulson.
- Approved Ordinance 287—Parks Ordinance after the second reading. In support: Paulson, Rennert, Reese, Knokey, Burford; Opposed: none.
- Approved renewing the current contract with Orenco for another 30 days. In support: Paulson, Rennert, Reese, Knokey, Burford; Opposed: none.
- Approved delegating the Mayor to contact Lane Council of Governments for availability of their assistance in recruiting a City Administrator and/or also acting as City Adminstrator pro tem. In support: Paulson, Rennert, Reese, Burford; Opposed: Knokey.
- Approved Resolution 610, proclaiming October as "Look me in the Eye" Month. In support: Paulson, Rennert, Reese, Knokey, Burford; Opposed: none.

#### From the October 21st regular meeting:

- Approved City Administrator's proposed recruitment process. In support: Paulson, Reese, Knokey, Burford; Absent: Rennert.
- Approved Resolution 611 Extending Workers' Compensation Coverage to Volunteers of the city of Lowell for the 2014-2015 policy year. In support: Paulson, Reese, Knokey, Burford; Absent: Rennert.
