Annual Budget Approved by Budget Committee

The Fire District Budget Committee recommended approval of the proposed budget for fiscal year 2015/2016 at its meeting on April 15th. Fire Chief presented no significant changes in the budget with a total proposed budget of \$645,626. The budget stays within the current tax rate of \$2.697 per \$1,000 of assessed property value.

The budget provides for two capital items: funds for the construction of a two-bay engine house at the Fall Creek station, and the replacement of a 2003 staff pickup. The budget also provides for a full-time Firefighter/EMT/ Trainer, a permanent part-time Firefighter/EMT, a half-time Fire Chief and a summer temporary part-time Firefighter/EMT. The budget also reflects a contribution to the Reserve Fund for future replacement of high cost equipment and vehicle.

The approved budget is posted on the District website at www.lowellfiredistrict.org. A Public Hearing on the proposed budget will be held at the Lowell Fire Station, 389 N. Pioneer Street, on May 19, 2015 at 7:00 p.m. The District Board Meeting will immediately follow the Budget Hearing. Both are open to the public.

May is Wildfire Awareness Month in Oregon

"Wildfire Knows No Season" is the theme for Oregon Wildfire Awareness Month this May. Wildfire Awareness Month is a public awareness campaign that highlights wildfire prevention education messages, events and opportunities for involvement statewide. This year's month-long education effort calls on citizens to be mindful of the growing potential for wildfires, and to follow basic fire-safety rules and precautions. State, local and federal fire agencies will be spreading the word about wildfire prevention and the steps Oregonians can take to stop most fires before they start.

BACKGROUND: Oregon's first Wildfire Awareness Week was proclaimed in May 2001. A multi-agency effort was led by the Office of State Fire Marshal and included the Oregon Department of Forestry, structural fire agencies (Lowell Fire District), insurance industry representatives and others. In 2008, the Keep Oregon Green (KOG) Association became the caretaker of the annual campaign. May 2015 marks the 14th year of the annual campaign, and the 7th year of Oregon's involvement in a proclamation that includes seven western states working together to address wildfire issues (MT, ID, OR, CA, NV, UT, SD).

Now's the time to make your property and home "Wildfire Safe". Here are some ideas that will help you avoid wildfire damage.

CLEAN The best place to start is with the house and the first 30 feet that extends out from it. The roof is the most vulnerable part of the home. Regularly clear leaves or needles from the roof and gutters, and cut back tree limbs that overhang the roof.

CLEAR Remove any combustible natural or human debris, such as leaves, branches, gas or paint cans, that collect near the home, under stairs, decks, and porches. Also important: Relocate firewood at least 30 feet from the home or store it in an enclosed shed.

LANDSCAPE Landscaping should contain low-growing, fire-resistant plants that are spaced carefully so as not to lead a fire to the home. Rake leaves and debris from the yard, mow grass, prune trees six to ten feet up from the ground, and keep plants well watered to prevent a surface fire from climbing into the crowns and carrying flames

from trees to the house. Properly placed deciduous trees can actually protect a home by blocking a fire's intense heat. Fuel breaks, such as driveways, gravel walkways, and green lawns can stop the advance of a fire by starving it of flammable vegetation. In the zone 100 to 200 feet from the home, trees may need to be thinned, though less intensively than those closer in, so canopies are not touching. Wildfire does not have to consume everything in its path. The more a homeowner can accomplish before fire season, the more it will improve a home's chances of surviving a wildfire.

It will give you some peace of mind knowing that if you leave your home for a stretch of time, it will still be standing when you return, if a wildfire were to happen. Emergency Medical Technicians Complete State Recertification

Every two years Emergency Medical Technicians statewide must complete a specific number and type of continuing education requirements to recertify their license with the Oregon State Health Division, Emergency Medical Services Section. The State requires EMTs to constantly review and update skills and knowledge and demonstrate the minimum standards of competency to maintain their license, whether the EMT is a volunteer or paid person, they all must meet the same national and state standards.

Lowell Fire District currently has three EMRs, five EMTs, one EMT-Advanced, one EMT-Intermediate and four Paramedics for a total of 14 medically trained personnel. In addition, one of our EMTs is currently enrolled in the Paramedic Program through LCC.

As with our neighboring Fire Districts (Dexter, Pleasant Hill and Goshen), Lowell Fire District does not transport patients to the hospital or operate an ambulance. Our fire districts are considered "First Response Agencies". In other words, we respond to provide immediate care and assistance while the transport unit (ambulance) responds from Springfield or Eugene. In fact, our local first response agencies are strictly prohibited by law from transporting patients, as we are not licensed, staffed or supplied to meet the strict state standards for transport.

Ambulance services are quite costly to operate, and it is much more cost effective for small fire districts like ours to provide immediate patient care and stabilization with local personnel and equipment, while transport units respond from centralized locations throughout the county. Supporting a local ambulance in each small district (such as Lowell, Dexter or Pleasant Hill) would be impractical, cost prohibitive and a waste of a valuable resource based on utilization in these areas.

Due to the high operational costs associated with an Ambulance Service, fire districts in the county have developed and provide EMS First Response. All First Response agencies in the county work very closely with the four transport agencies/ambulance services, in Lane County.

So, when you see a large rescue or ambulance-type vehicle responding to a medical emergency in a rural area, remember that it's your local volunteers responding to provide immediate, high quality medical care and that another unit, an "Ambulance", is on its way from the metro area. It's the method that gets qualified medical care to you the quickest and in the most cost effective manner.

Rural Volunteer EMTs like Lowell's EMTs, put in many, many hours of training every month to assure our patrons receive timely, quality emergency medical care while the ambulance travels the 15 to 20 miles from the metro area. Patients will receive quality emergency care until the ambulance arrives, and that is due to the dedication, skill and knowledge of your local volunteers.
