Lowell School District #71 Healthy and Safe Schools Plan

1. Responsible Person

3. Radon

The Lowell School District has developed a radon plan as required by ORS 332.167. Community members can access a copy of the radon plan here: [Lowell Radon Test](#). When testing is complete, the test results will be made public and posted to the website at Lowell.k12.or.us. Radon testing will be completed once every 10 years.

4. Lead in Drinking Water

Lowell School District has developed a plan to test for lead in the water in all faucets or fountains that are used for drinking or food preparation. The following components will be included:

- **Identify sources of lead:** The District will test all taps used for drinking or food preparation in the building to identify any lead problems. We will follow the Environmental Protection Agency's 3 T's Revised Technical Guidance to ensure that samples for lead are collected properly and from the right places. As well as use an OHA-accredited drinking water laboratory to analyze samples for lead.
- **Stop access:** The District will prevent access to water taps that have more than 20 parts per billion (ppb) of lead. This will include shutting off taps, covering water fountains, and providing bottled water to students and staff members.
- **Communicate:** Results from tests for lead in water will be made available to students, families, and the community as quickly as possible. Test results can be found by clicking: [test results](#).
- **Mitigate and correct:** The District will replace the sources of lead in building plumbing. Again, following EPA 3T's Guidance.
- **Ongoing Monitoring:** Testing will be done every five years or on an as needed basis. All testing will be in compliance with Oregon Health Authority guidelines.

5. **Lead Paint**

In order to comply with the United States Environmental Protection Agency's Renovation, Repair and Painting Program Rule, Lowell School District staff member, Ben Silebi, who is certified by the Oregon Health Authority, will perform any work on "child-occupied facilities."

6. **Integrated Pest Management**

Lowell School District has School Board adopted an integrated pest management plan as required by ORS 634.700 through 634.750. Community members can access a copy of the IPM plan here: [Lowell Pest Management](#).

7. **Communication**

The Lowell School district will make all test results and detailed information explaining the test results available to the public within 5 business days of receiving the results. Results will be made available by posting the results on the district website at Lowell.k12.or.us, sending notice of the results over the email system, and making the results available in hardcopy at the main administration office.
