The Lowell Wrestling team placed 4th overall in the State 1A/2A Championships last weekend and crowned another champion for Lowell. Junior **Kasey Erwin**, bested his effort last year when he won 2nd. Ranked first in the 132# weight class with a record of 26-5 this year, Kasey won with a major decision (9-0) in the first round. In the second round he won by fall in 4:48 then won by decision in the first place match.

Building Program Update

On February 6th, we met with the local Expert Group. The Expert Group members who participated were Chad and Richard Lybarger ~ Brother' Plumbing, Jerry Valencia ~ Bridgeway Construction, Jason Pickett ~ Parent and Facilities Expert, Jason Prenovost ~ J & K Electric, Brian Chittim ~ James Heating, John Murray ~ Lane Electric, and Tim Gribble ~ Preferred Construction. The architect from GLaS, Chris Walkup, and Dr. Hanline briefed the group on the project, with an emphasis on the input from the User Group. The Expert Group gave great advice, both from a construction and a cost point of view. From the input, the architect is now defining the initial specifications and systems that will be used for the project.

Building Program Process Dates

- ◆ May 15th **Expert Group Meeting**, from 5:30 – 9:00 pm, brief the experts and receive input on the specifications and systems.
- ◆ May 31st, **User Group Meeting**, brief and receive final input.
- ◆ June 1st - September 13th, **Architect** will finalize specifications and scope of project, including a formal cost analysis.
- ◆ September 13th, **Expert Group Meeting**, from 5:30 – 9:30, brief the experts and seek their point of view on the costs and specifications associated with the project.
- ◆ On September 24th, **School Board Meeting**, brief and seek approval on the final specifications and design development.
- ◆ September 24th – February 4th, **Architect** designs the final and complete plans and specifications.
- ◆ February 4th, 2019, **Expert Group Meeting**, brief and seek input on the constructability of the plans and specifications, the best way to phase the project, and the approach to packaging the bid documents, including additive and deductive alternates.
- ◆ March 1st – April 8th, 2019, **Solicit Bids**
- ◆ April 22nd, 2019 – **School Board**, Awards Bid
- ◆ June 17th, 2019 – **Construction Begins**

Open Enrollment Period Open for Lowell School District — March 1 through 31st

Lowell School District has chosen to participate in Open Enrollment since the enactment of Oregon House Bill 3681 in 2012. The law allows students to transfer to school districts outside of their legal residence, if a parent completes an Open Enrollment form and submits it to the District that the student wishes to attend. The form must be submitted within the Open Enrollment period, which is March 1 through April 1, 2018.

Outdoor Burning Season Opens March 1

The outdoor burning season opens in the City of Lowell on March 1 and runs through May 31. City regulations for burning are provided below. All outdoor burning is also subject to the Lane Regional Air Protection Agency (LRAPA) and residents should check their advisory hotline at **541-726-3976** or **www.lrapa.org**.

Prohibited:

- The burning of any refuse, garbage, or other waste products
- The burning of any construction or demolition waste
- Field, ditch or weed burning
- Commercial or industrial burning as defined by LRAPA
- The burning of wet woody yard trimmings, leaves and grass clippings

Allowable:

- Fires initiated for firefighting training purposes
- Recreational fires used for cooking with fire in a fireplace, barbecue set; or an outdoor fireplace, fire ring, or pit fueled with cut and split firewood
- Bonfires or religious ceremonial fires as approved in writing by LRAPA and the LRFPD
- The burning of clean woody yard trimmings, leaves and grass clippings on LRAPA approved burn days in October, March, April and May



Whenever possible, choose other ways to dispose of yard debris. Chipping, composting and hauling are alternatives. The City of Lowell also maintains a green waste drop-off site at the Wastewater Treatment Plant, located at 240 South Moss Street. The facility is open the last Saturday of every month from 10:00 - 12:00. Residents may drop off acceptable materials at no charge. Proof of residency is required, and may be confirmed with a recent water, electric, cable or telephone utility bill.

Acceptable Materials:

Tree limbs
Leaves
Soft, pliable vines
Twigs, branches, and woody vines up to 6" diameter and 10' long
Similar garden waste

Unacceptable Materials:

Dirt or sod waste
Animal waste
Herbicides, Fertilizers, or Insecticides
Treated Logs or lumber
Stumps or stump grindings
Material from contractors or commercial firms

Board and Committee Vacancies

Lowell City Council Actions

This report of actions taken by the Lowell City Council is a regular feature of this newsletter and is provided to inform citizens of recent decisions made by the council.

At the February 6th study session, the following topics were addressed:

- Discussed Grant Appropriations Resolutions: Resolution 685, for a grant in the amount of \$32,000 from the Oregon Parks and Recreation Dept. to update the Parks and Recreation Master Plan; Resolution 686, a grant in the amount of \$30,000 from the Oregon Dept. of Land Conservation and Development to develop a Downtown Master Plan; Resolution 687, a grant in the amount of \$1,000 from the Dept. of Land Conservation and Development for an update to the Land Development Code; and, Resolution 688, for a grant in the amount of \$400 from the Lane Library League for equipment and software.
- Discussed Budget Appropriation and Transfer Resolution 689, a resolution providing for budget transfers and making appropriation changes for FY 2017-2018 to increase the Police and Community Development, BBJ Festival and Debt Service appropriation authority to provide for unforeseen expenditures.
- Discussed Utility Bill Adjustments – information on a catastrophic water leak event that occurred, and information for possible changes to policy.
- Discussed Management Responses to the City Auditor addressing the deficiencies in the City of Lowell Fiscal Year 2017 Financial Audit Report.
- Reviewed City Council Guiding Principles.
- Reviewed 2018 Strategic Plan.
- Received an update on Irrigation System Projects.

Study sessions are held for the City Council to receive background information on City business and to give Council members an opportunity to ask questions and express their individual views. No decisions are made, and no votes are taken on any agenda item. The public is invited to attend, however, there is generally no public comment period.



NOTICE OF DIRECTOR VACANCY: Oakridge District (Includes Lowell/Fall Creek)

The term of office for one director in the Oakridge District on Lane Electric's board of directors will expire on May 29, 2018. The Nominating Committee is accepting applications from members who have an interest in their communities and feel a civic responsibility to their neighbors. The committee will develop a strong slate of candidates that will be presented to the members in an election in May. Directors are elected to three-year terms and must live in the district in which they apply. The incumbent director will be seeking reelection. Interested members may apply via the Position Filing process or the Petition Filing process.

Because Lane Electric Cooperative is a corporation, directors have the same basic duties and responsibilities as a director or officer of any other public or private corporation during their three-year term. Primary duties include setting policy, approving budgets, contractual considerations, working with the general manager, and monitoring the operations of the Cooperative.
