### LOWELL SCHOOLS: We're on the Move...

Dear Community,

"We have almost survived another winter in Lowell. Knock on wood, we have been very blessed to have had only one delay and no closures yet this year. I realize that kids and staff alike love the "snow day" phone call in the morning but with the groundbreaking for the bond happening at the end of school, we need to ensure that our school year stays on schedule."

The above quote is how I initially started my letter to you all in February.... As you now know, that backfired enormously! I am sorry about that and will take full responsibility for Snowmaggedon 2019! However, we made it through the storm with minimal damage in the district and we are so thankful to all the staff and community members that stepped up and helped during the time of need.

As the storm took place, it became even more apparent what a great place this is to be. Whether it be community members and staff plowing streets, parking lots and driveways, supplying residents with warm meals during the day and the fire station opening their doors to allow the community to get warm and charge their devices – Lowell/Fall Creek is truly a remarkable community with even more remarkable people.

Currently, we are in the process of creating the budget for next school year. The governor proposed an \$8.97 billion budget to the Ways and Means Committee which countered with an \$8.87 billion budget. Although the \$100 million seems like a huge gap, this is the closest they have been in years during this initial budgeting process. We will continue to keep our eyes on this very closely as we are building our budget based on these numbers. On another note, the board has approved the school calendar for next year. You can find it on our district website.

As far as the building projects are concerned, we had a pre-bid mandatory walkthrough which was very well attended. We will be opening bids in early April and awarding them shortly thereafter. Once this takes place, contracts need to be signed and the building renovation can finally begin. This has been an amazing learning experience to me, seeing all of the pre-building work that needs to take place before construction can begin. We are working diligently to ensure all i's are dotted and t's are crossed in order to be prepared for the construction to get underway. This will surely be a VERY busy year in the District. I would say looking back over the last five years, the staff and community have embraced the many changes that have taken place and everyone is excited to continue to make this district a desired destination for education.

On another note, I had the great pleasure to attend the College and Career Readiness night at the High School on March 20<sup>th</sup>. It was amazing to see all of the very talented students we have in this district. The students were in peak form during the performances courtesy of the drama and music department. Their performances were incredible and it fills me with joy knowing that I get to watch each student grow on a daily basis. Well done Lowell Jr/Sr High students and staff. Truth be told....I may have shed a tear or two during the powerful performances!

Vince Lombardi once said, "Perfection is not attainable. But, if we chase perfection, we can catch excellence." As a school district, we will continue to strive for perfection, knowing full well that if we continue to do so we will reach excellence. Not only are we on the move, we are well on our way!

#### **Outdoor Burning Season Open**

The outdoor burning season opened in the City of Lowell on March 1 and runs through May 31. City regulations for burning are provided below. All outdoor burning is also subject to the Lane Regional Air Protection Agency (LRAPA) and residents should check their advisory hotline at 541-726-3976 or <a href="https://www.lrapa.org">www.lrapa.org</a> prior to burning.

#### Prohibited:

- The burning of any refuse, garbage, or other waste products
- The burning of any construction or demolition waste
- Field, ditch or weed burning
- Commercial or industrial burning as defined by LRAPA
- The burning of wet woody yard trimmings, leaves, and grass clippings

#### Allowable:

- Fires initiated for firefighting training purposes
- Recreational fires used for cooking with fire in a fireplace, barbecue set; or an outdoor fireplace, fire ring, or pit fueled with cut and split firewood
- Bonfires or religious ceremonial fires as approved in writing by LRAPA and the LRFPD
- The burning of clean woody yard trimmings on LRAPA approved burn days in October, March, April and May



Whenever possible, choose other ways to dispose of yard debris. Chipping, composting and hauling are healthy alternatives. The City of Lowell maintains a green waste drop-off site at the Wastewater Treatment Plant, located at 240 South Moss Street. The facility is open the last Saturday of every month from 10:00- 12:00. Residents may drop off acceptable materials at no charge. Proof of residency is required, and may be confirmed with a recent water, electric, cable or telephone utility bill.

#### Acceptable Materials

- Tree limbs
- Leaves
- · Soft, pliable vines
- Twigs, branches, and woody vines up to 6" diameter and 10' long
- Similar garden waste

#### Unacceptable Materials

- Dirt or sod waste
- Animal waste
- · Herbicides, Fertilizers, or Insecticides
- Treated Logs or lumber
- Stumps or stump grindings
- Material from contractors or commercial firms

#### **Public Notice of Intent to Abate**

In April of each year, the City is required to provide the public with a copy of LRC 5.122 regarding the abatement of noxious vegetation. Noxious vegetation is defined as poison oak; poison ivy; blackberry bushes that extend into a public thoroughfare or across a property line; vegetation that is a health hazard, fire hazard, or traffic hazard; weeds or grass more than 12 inches high; weeds or grass going to seed; and noxious vegetation does not include agricultural crops unless that crop is a health, traffic, or fire hazard. Prior to any citation or abatement action, the property owner or person in charge of property will be provided with a minimum 10 days' notice to abate the vegetation. A copy of LRC 5.122 is provided on the next page for your reference:

**\*\*5.122 Owner Responsibility.** No owner or person in charge of property may allow noxious vegetation to be on his property or on the public right-of-way abutting his property. It shall be the duty of an owner or person in charge of the property to cut down or to destroy noxious vegetation. Exception: For parcels one acre or larger in size, noxious vegetation need only be controlled for a distance of 20 feet from an adjoining property where development has occurred and is not required to be controlled adjoining undeveloped property unless specifically requested by the owner of the undeveloped property."

- Approved Professional Services Contract Amendment with The Urban Collaborative


